

## Call for Manuscripts

*Teaching Social Studies*, the joint publication of the New York and New Jersey Councils for the Social Studies, is a peer-reviewed, electronic journal published twice yearly (Winter/Spring, Summer/Fall). The editors issue a call to submit manuscripts for a special issue (Summer/Fall, vol. 20, no. 2), focusing on **imperialism and its various effects**. This issue will feature Dr. Jeremiah Clabough (The University of Alabama-Birmingham) as a guest co-editor.

## Imperialism

The theme of imperialism is regularly featured in our social studies curricula and classrooms, but the manner in which such policies may continue to impact human decisions and behavior is vital for students to grasp. Articles focused on this subject may choose to focus on any of the following: **the impact of economic/political/social exploitation of one nation by another; the interdisciplinary connections around the theme of imperialism; pedagogical approaches that may prove useful for teachers and students; imperialist policies and their impact on international relations; the continuing impact of colonialism and imperialism in developing countries; and the contradiction of democratic countries employing imperialistic practices through their interactions with other countries**. These topics are not meant to exclude other related topics which authors may develop. Activities in articles should draw upon K-12 civic, economic, geography, and/or history standards from the C3 Framework by the National Council for the Social Studies. Furthermore, the activity or activities should strengthen K-12 students' social studies disciplinary literacy, thinking, and argumentation skills through exploring a topic or topics connected to imperialism.

## Submission Guidelines

Submissions from all social studies disciplines as well as from interdisciplinary perspectives are welcome. Submit manuscripts as a file

Manuscripts must be:

- Original, accurate, meet submission guidelines, in good form editorially, and not under consideration elsewhere.
- Submitted in Microsoft .doc or .docx format.
- Submitted in *Publication Manual of the American Psychological Association* (6<sup>th</sup> edition) style, and written in English.
- Formatted in *Times New Roman*, size 12 font, double spaced with graphics embedded in text in .gif or .jpg file formats.
- From 1000-4000 words in length, *excluding references*.
- Please submit your manuscript with the following provisions:
  - The manuscript has not been published elsewhere (excluding manuscripts which the editors have requested reprinting privileges)
  - The manuscript is not under consideration for publication elsewhere

**Please include:**

- A title page with complete contact information for all authors, including address, telephone, and email
- Manuscript that is void of author(s) name and institution(s).
- An abstract of 100 words or less following the title page.
- A biographical sketch of each author of 30 words or less at the end of the manuscript.
