Oklahoma State University is accepting applicants for a tenure-track Assistant Professor faculty position in Curriculum Studies within the School of Teaching, Learning and Educational Sciences in the College of Education and Human Sciences, beginning August 2021. This position is primarily assigned to the OSU-Stillwater campus, with some OSU-Tulsa teaching responsibilities. The Curriculum Studies Program is seeking an outstanding scholar and a leading professional.

The Curriculum Studies program prepares K-20 curriculum leaders from various disciplines, professors of education, curriculum developers and researchers, and educational leaders in various settings. The program's mission is to cultivate scholars' and leaders' self-reflexivity, broad and deep interdisciplinary understanding of curriculum studies knowledge, and ability to create and use research and scholarship for the benefit of diverse local, national, and international communities. The program offers Curriculum and Leadership Studies Option in Teaching, Learning, and Leadership MS degree, PhD degree in Curriculum Studies (including three Options: Curriculum and Leadership, College Curriculum and Teaching, and International and Peace Curriculum), and a Graduate Certificate in College Teaching. The OSU Curriculum Studies Project and William F. Pinar Endowed Curriculum Studies Fund also provide unique opportunities to bring internationally-renowned curriculum scholars together with students, teachers, faculty, and other community members to address important curriculum issues for the advancement of the field.

RESPONSIBILITIES:

The successful candidate will value the Oklahoma State University land grant mission and embrace the opportunity to make a positive impact on the community through high-quality and integrated teaching, scholarship, and service. This tenure-track faculty member will contribute to the program and the field of curriculum studies and will have opportunities to collaborate with nationally and internationally recognized faculty in

research and program development to increase the positive impact of the program on the state of Oklahoma, the region, the nation, and the international world. Major responsibilities include:

- Establishing a scholarly research agenda through publications, grant writing, and presentations, and showing the potential for leadership in advancing the field of curriculum studies;
- Teaching courses in areas such as curriculum history, curriculum theory, curriculum design, K-20 curriculum, pedagogy, cultural diversity, college curriculum and teaching, and international and peace education;
- Recruiting, advising, and mentoring graduate students;
- Providing service to departmental, college, and university committees, and participating in professional organizations at local and national/international levels; and
- Collaborating with faculty in other programs across the campus and engaging in purposeful University outreach to foster productive relationships with local communities.

REQUIRED QUALIFICATIONS:

- Ed.D. or Ph.D. with an emphasis in Curriculum Studies or closely related area;
- Record of scholarly productivity and evidence of emerging research agenda;
- Teaching experience at the levels of K-12 schools and/or higher education; demonstrated record of or potential for teaching excellence at the university level; record of effective online and/or hybrid teaching;
- Strong working knowledge of various research methodologies;
- Ability to build productive professional relationships with public schools, colleges, and local communities; and
- Evidence of professional service and of efforts in seeking external grant funding.

PREFERED QUALIFICATIONS:

- Research expertise in the area of curriculum and teaching in higher education;
- Expertise in international and peace curriculum and nonviolence education;
- Expertise in both qualitative and quantitative research methodologies;
- Experience in advising graduate students; and
- Experience in obtaining and engaging externally funded projects

SALARY AND BENEFITS: Salary will be commensurate with experience and qualifications. Benefits include comprehensive medical and retirement plans.
